

# Scholarships Competition Second Level Academic Diplomas

## REGULATION

**Deadline: September 15<sup>th</sup> 2022**

Fondazione Francesco Morelli and IED Istituto Europeo di Design offer **10 scholarships**, covering 50% and 100% of the tuition fee, for the Second Level Academic Diplomas 2022/2023.

Fondazione Francesco Morelli aims to promote the right to education of talented young creatives, by removing socio-economic barriers that could preclude access to studies, offering **6 Scholarships** covering the 100% of the tuition fee for the Second Level Academic Diplomas 2022/2023.

IED Istituto Europeo di Design offer **4 Scholarships** covering the 50% of the tuition fee for the Second Level Academic Diplomas 2022/2023.

Locations involved are Milan and Turin.

## How to apply

Participate in IED Master Scholarships students are demanded to get registered and upload required documents not later than **(GMT+1 - Italian time)**:

- h 23.59 of **15<sup>th</sup> September 2022**.

**Step 1.** Read carefully the Regulations.

**Step 2.** Pick a course of choice.

**Step 3.** Get registered by filling in the form available at [ied.edu/news/scholarships-competition-for-22-23-master-of-arts-courses](https://ied.edu/news/scholarships-competition-for-22-23-master-of-arts-courses)  
Once registered, you receive an email confirmation with the credentials to enter your Personal Area where you can upload required papers. A IED Advisor will contact you to support you in the process.

**Step 4.** Once the material collection is ready, enter your Personal Area with the given credentials and upload the required documents.

**Step 5.** At the end of the competition if your skills are in line with those required for the admission to the course of your interest, you will be contacted by your Admission Advisor in order to join the online interview with the coordinator of the course.

**Step 6.** Scholarships' winners have 3 days to confirm their acceptance and 5 days to complete your application to the Master course of your choice.

# TERMS AND CONDITIONS

## 1. Preconditions

- 1.1 IED - Istituto Europeo di Design S.p.A. (hereafter referred as IED) and Fondazione Francesco Morelli wish to promote the interaction between young designers promoting specific contests, in order to assign Scholarships for their Second Level Academic Diplomas in Transdisciplinary Design.
- 1.2 Following this initiative IED and Fondazione Francesco Morelli promote the **Scholarship** Contest through the dedicated website [ied.edu/news/scholarships-competition-for-22-23-master-of-arts-courses](http://ied.edu/news/scholarships-competition-for-22-23-master-of-arts-courses) and their social pages.
- 1.3 The purpose of the contest is to assign **n. 4 Scholarships** for attendance of IED Second Level Academic Diplomas for students who are matriculated in the academic year 2022/2023, covering 50% of the tuition fee of the program of choice and **6 Scholarship**, offered by Fondazione Francesco Morelli, covering the 100% of the tuition fee of the program of choice.
- 1.4 The Contest is controlled by the present Regulations and will take place, through all the phases detailed below, from **July 22<sup>nd</sup>, 2022**, date of publication of the Competition Announcement, until (**GMT+1 - Italian time**):
  - h 23.59 of **September 15<sup>th</sup> 2022**.The final ranking will be published on [ied.edu](http://ied.edu) not later
  - of **October 15<sup>th</sup> 2022**.

## 2. Participation requirements and deadlines

- 2.1 Participation in the contest is subject to registration to the website [ied.edu/news/scholarships-competition-for-22-23-master-of-arts-courses](http://ied.edu/news/scholarships-competition-for-22-23-master-of-arts-courses) and to the acceptance of the present Regulations.
- 2.2 Participation is strictly reserved to all Candidates who have reached 18 years at the moment of application, in possession of a bachelor degree. Graduands are eligible, as long as the documentation certifying the qualification necessary for enrolment in the course is delivered to IED by the beginning of the first exam session of the first year of the course (for the Second Level Academic Diplomas). Candidates have to meet the specific requirements fixed in the guidelines and informative materials of each single course. Candidates need to show proficiency of the course language (B2 level minimum is demanded).
- 2.3 Students who are already enrolled in a **1<sup>st</sup> Level Master** course or in any other Academic and Afam Course are not allowed to be enrolled in a Second Level Academic Diploma or in other academic and Afam courses at the same time.
- 2.4 To apply for the Scholarship offered by Fondazione Francesco Morelli, Candidates must demonstrate that they belong to an income bracket of no higher than €35,000, by presenting the ISEEU form or an ISEE corrente certification (if the employment or financial

situation of the family has worsened compared to the calculation made for the standard ISEE certification).

- 2.5 ISEE certification may, in any case, be subject to verification on the part of the competent authorities. Untrue declarations will be subject to the application of the pertinent regulations in force, and the candidate will not be eligible for the award of a Scholarship or of any additional contributions.
- 2.6 IED and Fondazione Francesco Morelli employees and consultants are not allowed to participate in the Contest.
- 2.7 By providing the personal data required to register, the Candidate knows the legal consequences of supplying false data thus he's called to supply precise, complete, true and correct data.
- 2.8 Processing of personal data will be respectful of the attached information as per **D. Lgs. n. 2016/679** on personal data protection. None of the data required for registration can be considered sensible under the above-mentioned decree.
- 2.9 The Candidate is informed that knowledge of his Username and Password by third parties will grant them access to the Candidate's personal area of the site in his name. The Candidate is thus bound to keep the secrecy of his access data with the maximum diligence.
- 2.10 The Candidate will be held liable or accountable for any damage and damaging consequence occurred to IED or Fondazione Francesco Morelli for the infringement of the rules stated above.

## 3 Contest

- 3.1 Each registered Candidate can participate to the Contest filling in the **registration form**, specifying the chosen course and the location in which the course is held. Once received the access credentials, Candidates have to upload in **their Personal Area** the requested documents not later than (**GMT+1 - Italian time**):
  - h 23.59 of **September 15<sup>th</sup> 2022**.
- 3.2 Each participant can apply for only one course and one location.
- 3.3 The Candidate grants to hold IED, Fondazione Francesco Morelli, and their assignees harmless, materially and in court, from any loss, damage, liability, cost or expense, including legal costs.

## 4. Required documents and Concepts

- 4.1 In order to be considered eligible, each candidate will be asked to provide:
  - Pre-enrolment form and Privacy-sheet duly and signed.
  - Motivation letter in english.
  - Transcript.
  - Copy of passport.
  - Internationally recognized (e.g. Ielts) certificate of knowledge of english, if different from the mother tongue (alternatively it is possible to hold an interview through skype). The minimum level requested for the application is B2.
  - ISEEU or ISEE corrente certification (only for the Scholarship offered by Fondazione Francesco Morelli).

- A video of themselves motivating the reasons behind their application, highlighting their possible contribution to the course and the goals they would like to achieve through it in terms of benefits to the society or their communities.

**4.2** The video must be not longer than 60 seconds. Youtube or Vimeo links must be copied in a document and uploaded in the section Scholarship Contest.

## 5. Scholarships

**5.1** IED offers **n. 4 Scholarships** covering 50% of the tuition fee for the chosen course. Winners of Scholarships have to pay the enrolment fee plus the half of the tuition fee. Fondazione Francesco Morelli offers **6 scholarship** covering the 100% of the tuition fee.

Winners of scholarships have to pay the enrolment fee.

**5.2** For the second year, the renewal of the Scholarship is guaranteed (exception made for the enrolment fee, which is always excluded from Scholarships) only if the student passes all the exams planned in the study plan for the first year with an average mark not inferior than 28/30. If this conditions are not satisfied, the Scholarship will not be confirmed.

**5.3** The Scholarship will cover just the tuition fees. Enrolment fee, housing and other costs shall be covered by the winners.

**5.4** Scholarship will be assigned - taking into consideration the designated course - according to the results of the profile and video (concept) evaluation and the result of the interview with the coordinator. The evaluation will be conducted according to the unquestionable judgement of the Panel. To apply for the Scholarship offered by Fondazione Francesco Morelli, Candidates must demonstrate that they belong to an income bracket of no higher than € 35,000, by presenting the ISEEU form or an ISEE corrente certification. If there is more than one Candidate with the same score in the final ranking, priority will be given to the Candidate account with the lower ISEE income certification. IED and Fondazione Francesco Morelli reserve themselves the right not to assign one or more Scholarships, in case the evaluation, according to their unquestionable judgment, is not considered suitable for the admission.

**5.6** IED and Fondazione Francesco Morelli reserved themselves the discretion not to activate one or more Courses, in case the minimum number of students has not been reached or if the necessary requirements for didactic logistic and administrative support fail for any reason. In these cases, the Scholarships for the courses that haven't been activated will not be assigned; winner will not have the right to ask for any kind of reimbursement.

**5.7** The combination of the reductions and facilitations mentioned in the former articles is not allowed.

## 6. Scholarships locations and courses

Scholarships will be assigned according to the scheme below:

### IED Milano

2 scholarships covering 50% of the tuition fee

3 scholarships, offered by Fondazione Francesco Morelli, covering 100% of the tuition fee

### IED Torino

2 scholarships covering 50% of the tuition fee

3 scholarships, offered by Fondazione Francesco Morelli, covering 100% of the tuition fee

## 7. Publication, Selection of winners and Panel

**7.1** The selection will take place:

- by **September 27<sup>th</sup>, 2022**.

through the evaluation of the documents, the video evaluation and through an interview with the Course Coordinator. The evaluation will be conducted by a Panel made of directors or representatives of Schools.

**7.2** The evaluation will be made by the Panel, unquestionably.

**7.3** Students will also be asked to join an online selection interview with the course coordinator and will be evaluated with a score from 0 to 5 according to the following criteria:

- motivation of the candidate
- Intellectual vividness and personal interest
- design aptitude
- skills related to the course of interest.

The total score represents the final ranking.

For the Scholarship offered by Fondazione Francesco Morelli, If there is more than one Candidate with the same score in the final ranking, priority will be given to the Candidate account with the lower ISEE income certification.

**7.4** The winners will be notified by email by a IED representative. The winners must send a formal acceptance letter by email, within 3 days after the result is received. If the winner fails to meet this requirement, the Scholarship will be automatically considered as "refused" and the Panel may decide, unquestionably, to grant it to another Candidate.

After the winner accepts the Scholarship, he/she will have a 5-day deadline to enrol in the course for which the Scholarship was granted paying the enrolment fee of the course.

## 8. Conditions and general terms of participation

- 8.1** Incomplete entry cards are not valid.
- 8.2** Incomplete entry cards which do not meet the requirements, do not have the elements referred above, contain wrong or unreadable data, or sent after:
- h 23.59 of **September 15<sup>th</sup> 2022**.
- 8.3** IED and Fondazione Francesco Morelli discharge any external responsibility such as delays due to malfunctioning of devices.

## 9. Exclusion of warranties

- 9.1** IED and Fondazione Francesco Morelli do not states nor grants thatthe Website and its functions are flawless or satisfy certain Standards, needs or requests of the User.
- 9.2** IED and Fondazione Francesco Morelli do not states nor grants that the use of the Website and its functions will be prompt, uninterrupted, assured or flawless, nor that the information and contents on the Website are correct, truthful and/or reliable.
- 9.3** Under no circumstance, IED and Fondazione Francesco Morelli will be held liable or accountable towards Candidates or third parties for any damage consequent, accidental, indirect or of any other nature, predictable or unpredictable, deriving from the use or the impossibility to use the Website.
- 9.4** IED and Fondazione Francesco Morelli will not be liable for imprecisions, inaccuracies or delays due to force majeure.
- 9.5** IED and Fondazione Francesco Morelli are not liable for improper use of the Website and does not grant nor authorize its use in any application potentially dangerous for people or properties.
- 9.6** The Candidate grants that he will hold IED and Fondazione Francesco Morelli harmless from any consequence deriving for improper, illicit or undue use of the Website.
- 9.7** Consequently, the Candidate declares himself solely liable towards IED, Fondazione Francesco Morelli and third parties for any and every behavior or fact punishable by law during the utilization of the Website.

## 10. Obligations of the candidate

- 10.1** The Candidate binds himself:
- not to divulge or cede, directly or indirectly, usernames, passwords, and login data to the Website;
  - not to reproduce, copy, distribute in part or in whole, by commercial or non-commercial ends, the Website, the Concepts and IED Contents published on the Website, by no means, not electronic nor printable;
  - not to perform any action that can compromise the security of IED website.
- 10.2** It is forbidden to the Candidate:
- to submit, upload and/or publish material protected by copyright, unless the Candidate is the owner of such right or has been authorized by the owner;
  - to submit, upload and/or publish material that disclose industrial secrets unless the Candidate is the owner of such secrets or has been authorized by the owner;

- to submit, upload and/or publish material that violates intellectual property rights, privacy rights or rights deriving from advertising contracts;
  - to submit, upload and/or publish material that is illicit or against law, order and public decency;
  - to submit, upload and/or publish material containing improper expressions or violating someone else's dignity or decency;
  - to submit, upload and/or publish sexually explicit material;
  - to submit, upload and/or publish promotional material, junk mail, spam or any other unrequested or unauthorized form of solicitation;
  - to falsify his identity;
  - to submit, upload and/or publish material containing computer viruses and/or other codes or files or programs created to interrupt, destroy, damage or limit the operation of software, hardware, websites or telecommunication installations belonging to IED or third parties.
- 10.3** Each violation of the requirements stated by this article will allow IED and Fondazione Francesco Morelli nullify the present agreement, with the right of IED, Fondazione Francesco Morelli or third parties to be refund for the damage.

- 11.1** This Agreement and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with Italian law.
- 11.2** The court of Milan shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Agreement or its subject matter or formation (including non-contractual disputes or claims).
